What is the COVID19 Emergency Benefit?

The Extended COVID19 Emergency Benefit is available to eligible OW and ODSP recipients who are facing extra hardship because of the COVID-19 pandemic. As of May 1, 2020, it is a monthly benefit that, once approved, will be sent to you in May, June and July 2020 (no longer a one-time payment). It is a flat monthly rate of \$100/month for singles and \$200/month for families.

Who is eligible?

It is available to anyone on ODSP or OW who is NOT also receiving CERB. (There are some exceptions to this such as any case where CERB is being treated as fully exempt, such as: youth under 18, adults in full-time secondary school, and full-time post-secondary students).

How do you apply?

If you received the Emergency Benefit in March or April and still qualify, you are supposed to receive the extended benefit **automatically** in May, June, and July. (Note: it is always good practice to double check your benefits are in place before the 18th of the month, to ensure funds will be on your statement at the end of the month).

If you have never received the benefit, and you qualify, a separate ODSP office has been established to handle applications. For that reason, there are a few ways to apply for this benefit (please read page 2 for a voicemail script and email template):

OW Recipients: Call your worker directly to request the benefit

ODSP Recipients:

- Call your ODSP office to request the benefit through the receptionist
- Call the Emergency Benefit Application Line 1-888-444-2412 and leave a voicemail
- Email <u>ODSP.EmergencyBenefit@ontario.ca</u> with your request
